**RIGHT HOME ANNOUNCES NEW SENIOR PROTECTION PLAN**

**-- Company Offers Free Independent Legal Counsel for Seniors --**

SAN DIEGO, CA (September 20, 2005) -- An innovative real estate program designed to make the home selling process more comprehensible and safer for seniors was unveiled today by Right Home at the California Association of Realtors convention in San Diego. Senior clients are under no obligation to use this service, and are free to select any attorney of their choice. If this occurs, Right Home will pay the attorney up to a certain amount, and the seller will be responsible for any amounts in excess.
